1 **A Bill for an Act to amend the *Bankruptcy Act 1966*,**
2 **and for related purposes**

3 The Parliament of Australia enacts:

4 **1 Short title**

5 This Act may be cited as the *Bankruptcy Legislation Amendment*
6 *Act 2009*.

7 **2 Commencement**

8 (1) Each provision of this Act specified in column 1 of the table
9 commences, or is taken to have commenced, in accordance with
10 column 2 of the table. Any other statement in column 2 has effect
11 according to its terms.

25 remuneration and an explanation of the likely impact of that
26 remuneration on the dividends (if any) to creditors.

19 (c) the decisions that may be made by the Inspector-General in

21 (d) the notification of decisions made by the Inspector-General.

22 *Repayment—trustee*

- 23 (4) The regulations may provide that, if the Inspector-General is
24 satisfied that a withdrawal by the trustee of funds from the estate of
25 the bankrupt for payment of the trustee's remuneration exceeds the
26 amount of remuneration the trustee is entitled to under this
27 Division, the Inspector-General may require the trustee to repay the
28 excess to that estate.
- 29 (5) The amount of the excess is recoverable by the Inspector-General,
30 as a debt due to the estate of the bankrupt, by action against the
31 trustee in a court of competent jurisdiction.
